

## On-Site Sewage Facility (OSSF) Information

### Local Contacts

Some counties, towns, and cities have authority over OSSFs located within their jurisdiction. To determine if you are in an area with a delegated program, refer to the attached table of local contacts for questions concerning your OSSF.

### Malfunctioning OSSF (Repair Needed)

OSSF repairs should be completed by a licensed OSSF installer or maintenance provider. Information on licensed individuals in your area may be found at:

- “Type and Level” dropdown box, choose either “OSSF maintenance provider” or “OSSF installer II”
- “County” dropdown box, choose your county.
- The resulting list will include all licensed maintenance providers or installer II whose address is in the chosen county. You will need to click on their name to obtain their phone number.

In some cases, repairs may be made by the system’s owner. Please check with your local authority (see list attached).
